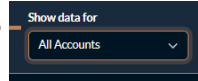


1. To check what accounts a widget is reporting, click the pyramid icon  at the top right of each widget.

4. Select the page you need with the Main Menu. 

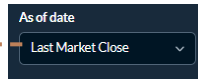

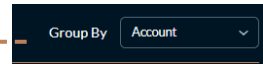
1. Use the “Show Data for” dropdown to select the account or group displayed.



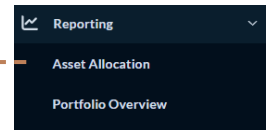
2. Select your report dates, or create a custom one (not available in all reports).



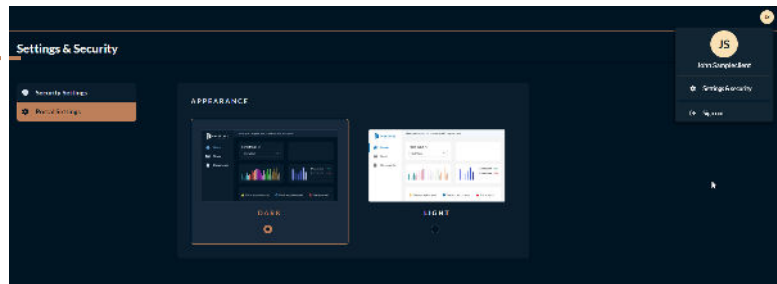
3. Change how data is displayed with the “Group By” option. (Not available in all reports).
