

**FACTS****WHAT DOES SEQUOIA FINANCIAL GROUP, LLC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Name, address, telephone, facsimile, email, tax ID, social security number, DOB, investment objectives
- Account balances, positions, and account history

**How?**

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Sequoia Financial Group, LLC chooses to share; and whether you can limit this sharing.

What we do	
How does Sequoia Financial Group, LLC protect my personal information?	SFG safeguards your personal information by limiting access to only those employees of SFG and its affiliates that provide products or services to you, to those who need access to your information to service your account, to those that must come into contact with your information as part of their job responsibilities with either SFG or an affiliate of SFG, or to outside vendors who are contractually bound to protect the privacy of your non-public information. In addition, SFG maintains physical, electronic, and procedural safeguards that meet applicable legal standards to protect your non-public personal information.
How does Sequoia Financial Group, LLC collect my personal information?	<ul style="list-style-type: none"> <li>SFG collects information furnished by you on account applications or other forms provided by you.</li> </ul>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>sharing for affiliates to market to you</li> <li>sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and non-financial companies. Our affiliates include Sequoia Tax Services and others that provide financial, tax, or advisory services.
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and non-financial companies.
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
